NOTABLE DECISIONS

APPELLATE DECISIONS

- Affirmance of summary judgment by the Kentucky Supreme Court in a premises liability action due to Plaintiff's failure to produce sufficient evidence of negligence against hospital. *Smith v. St. Claire Regional Medical Center*, No. 2023-SC-0528 (Feb. 8, 2024).
- Affirmance of summary judgment on unconstitutionality of statute, KRS 311.1939, which constituted special legislation. *Coleman v. CorneaGen, Inc.*, No. 2023-CA-0093 (Ky. App. Feb. 9, 2024).

TRIAL COURT DECISIONS

- Summary judgment on behalf of healthcare provider on statute of limitations grounds. *Missall v. Hillspring of Springboro*, Warren C.P. No. 22 CV 95338 (May 5, 2024)
 - Successful defense of a challenge to a hospital's COVID-19 vaccination policy. *Beckerich v. St. Elizabeth Med. Ctr.*, 563 F. Supp. 3d 633 (E.D. Ky. 2021).
